AFFIDAVIT of PROBABLE CAUSE

You affiant is a sworn member of the Pennsylvania State Police assigned to the Gibson Station.

In February of 2013, Sgt J. STEELMAN who is employed by the Woodstock Police Department in Georgia, forwarded his police report along with attachments and video recordings of interviews pertaining to the sexual abuse reported to his department by the victim. He related that on December 6th of 2013, he was notified of a female that arrived at the Woodstock Georgia Police Station to make a report of child molestation. Sgt. STEELMAN related that he directed Detective Ron HUGHES to conduct an interview of the woman identified as Moriah DANIELS. Moriah DANIELS brought her niece to the police department to make a report of sexual abuse.

Moriah DANIELS W/N-F 12/19/1975 age 37 of 508 Chieftan Woodstock GA 30188 (404) 993-2413 was interviewed on 12/06/2013 at the Woodstock Police Department by Detective Ron HUGHES. DANIELS related the following; she advised Detective HUGHES that several days ago, her niece whose name she said was was dropped off at her house by be her brother Eric DANIELS. Moriah DANIELS stated that the last time that she saw was when she was six years of age. Moriah DANIELS informed Detective HUGHES that last evening that younger sister was also dropped off at her house. Moriah stated that once the children were both in her home, began telling her about things that were happening and that have happened between her and her father. Moriah DANIELS related that sclosed to her that her father molested her since she was very young. told Moriah that she informed her stepmother April DANIELS about the abuse but said that April did nothing to stop the abuse.

AFFIDAVIT of PROBABLE CAUSE CONTINUATION

Moriah stated that [redacted] told her that the abuse occurred in several different states during the course of her life. Moriah DANIELS related that she is not very close with her brother Eric and related that he moves quite often. [redacted] disclosed that the most recent event of sexual abuse occurred at Breman Georgia at Yogi Bear's Jelly stone Park located at 106 King Street. Moriah DANIELS stated that her brother and his family have been moving from place to place ranging from Pennsylvania, South Carolina and now are residing in Georgia. Moriah stated that her brother Eric is currently residing with his two daughter's [redacted] and [redacted] and his wife April DANIELS and also a woman named Lauren. Moriah stated that [redacted] also informed her of a computer at her brother's trailer that allegedly contains pictures of underage girls being molested.

[redacted] of 508 Chieftan Woodstock GA 30188 (404) 993-2413 was interviewed on 12/06/2013 at the Woodstock Police Department by Detective Ron HUGHES. Detective HUGHES advised [redacted] that only tell him what she felt comfortable telling him due to the fact that he was setting up for [redacted] to be interviewed by a Forensic Interviewer at the Anna CRAWFORD Children's Center.

[redacted] did relate that she was sexually abused in Pennsylvania several years ago, which she reported to authorities but said that the charges were dropped because she stopped talking about the incidents involving her and her father. Alexa stated that at that particular time, she did not want her father to go to jail so she stopped talking to authorities about what had happened to her. [redacted] advised Detective HUGHES that the last time that she was molested was three weeks ago in Breman Georgia. She did indicate that her family at that time was staying at Jellystone Park and the Yogi Bear Camp when then sexual abuse occurred between her and her father. Detective HUGHES asked [redacted] if she was aware of any sexual abuse that may have occurred between her sister [redacted] and her father. [redacted] stated that her sister had never said anything to her about being sexually abused by their father, but related that she knew that she was because she saw videos and pictures of her sister being molested on her father's computer. She stated that the videos and pictures were stored on a hard drive, which is kept in the cabinet above the table in their camper. [redacted] related that this hard drive contained pictures of her, her sister and other children and videos of adult sexual activity. She stated that in the past her father would make her watch these videos in order to get her to participate in sexual activity with him and other people. Detective HUGHES then set up a forensic interview at the Anna Crawford Children's Center located in Cherokee County Georgia.



AFFIDAVIT of PROBABLE CAUSE CONTINUATION

Detective HUGHES related that Linda A. BANIK then conducted a Forensic Interview. Detective SCHAEFER of the Woodstock Police Department observed the Forensic Interview. During the interview, [redacted] related that the sexual abuse involving her father began when she was 7 years of age in Pennsylvania just after her father split up with a woman she identified as her ex-stepmother whose name she related was Dawn DANIELS. At that time Eric DANIELS resided in Susquehanna County. She stated that her father would make her perform oral sex on him and she would also have to give her father "hand jobs". She also stated that her father would also touch her vaginal area with his private area. She also related that her father would perform oral sex on her as well. Detective HUGHES related that based on information that [redacted] provided in her interviews, which she said that her father was in possession of child pornography that he kept in his possession. Detective HUGHES executed a search warrant on Eric DANIELS camper as well as the hotel room he was staying in. A hard drive, disks, journals, and several other items of interests were obtained in the search. A CD-R that was found in the camper contained 109 photographs of child pornography with children in various stages of undress and also depicting multiple acts of penetration and sodomy. The ages of the children ranged from infants to pre-teens. Detective HUGHES indicated that the videos and pictures that were obtained in the execution of the search warrant were many pictures and videos of Eric DANIELS performing oral sex on [redacted] as well as [redacted] performing oral sex on him.
